And the proclamation having been made the Court was in session, the following business came on to be considered:


CALL MEETING TO ORDER & ESTABLISH QUORUM - All Present



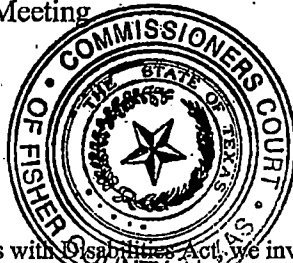
