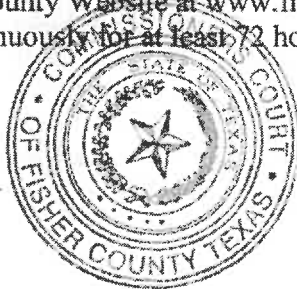
D. DELIBERATE/CONSIDER ACTION ON NEW BUSINESS ITEMS:
