## Fisher County Chamber of Commerce and Agriculture Minutes

### Wednesday, May 15, 2019

Meeting of the Fisher County Chamber of Commerce and Agriculture was called to order by Sarah McLen at 12:01 p.m. Attendees were Nancy Sparks, Rory Burroughs, Reid Cave, Richard May, Greg Pruitt, Randy Hodges, Jonelle Adelhardt, Tricia Hurt, Larissa Place, Stephanie Huston, Jeremy Dodd, David Smallwood, Lane Hicks, and Sarah McLen.

Sarah McLen updated those present that the draft of the Chamber's Bylaws will be forwarded to an attorney with the Texas Chamber of Commerce Executives association for review and will hopefully be available for adoption at the Chamber's June meeting. As such, no formal motions will be called for today and decisions made at this meeting will be by consensus of those present.

After reviewing April 10, 2019 minutes, Nancy Sparks noted that she was absent for the meeting, contrary to what the minutes reflect. The April 10, 2019 meeting minutes will be so amended.

Reid Cave presented financial statements through April 30, 2019 showing available funds of \$14,344.75 in CD #1, \$5,511.49 in CD #2, \$5,531.26 in Checking Account, and \$330.92 in Scholarship Fund. Total assets balance with liabilities and equity at \$25,518.42. Checks will be issued for \$200.00 to Lydia Miranda to refund security deposit for St. Joseph Catholic Church's use of the Pavilion May 4, 2019, and to Texas Chamber of Commerce Executives association for annual membership dues of \$160.00.

The above-named parties are hereby admitted as members of the Fisher County Chamber of Commerce and Agriculture.

Sarah McLen presented a verbal proposal from the Fisher County Commissioner's Court for the Chamber to have general operation of the Sheriff Posse Arena Grounds west of Rotan, with the following exception: Operation of the Sheriff Posse Arena Grounds for mud bog events will be leased directly to Fisher County Red Dirt, LLC by Fisher County, who owns said property, per the Fisher County Commissioner's Court. This will absolve the Chamber of any involvement with any Mud Bog events and/or Fisher County Red Dirt, LLC, to expressly exclude the Chamber as well as its directors, officers and members from any and all liability. All present were agreeable to this. Sarah McLen will visit with Judge Holt to present this information and to update the Chamber's lease agreement for the Sheriff Posse Arena with Fisher County. Going forward, the lease will be reviewed and updated annually.

Greg Pruitt gave an update on the Farm Sale, which had gross income of \$154,785.45. The Chamber will receive 50% of the net proceeds once expenses have been paid. Outstanding settlement amounts are due Jerry Deen, John Morgan, the Rotan Gin, and possibly for fuel. Pruitt will coordinate paying expenses with Reid Cave and an update will be provided at the June meeting of the Chamber.
