

GCDs located in GMA 6 are Clear Fork GCD, Gateway GCD, Mesquite GCD, Rolling Plains GCD, and Upper Trinity GCD.

The technical consultant may also report on legislative or statutory changes that may affect the joint planning process.

- 8. Receive commitments, if any, from affected Districts to generate data needed to improve robustness of groundwater availability modeling for future planning cycles.
- 9. Report from Legislators and/or their staff
- 10. Discussion receive report on the status and any anticipated changes to each District's Groundwater Management Plan and/or Rules.
- 11. Report from GMA 6 Administrator
- 12. Consider and Act set date, time, and place for the next meeting
- 13. Adjourn
