8. Report on groundwater availability model updates for the Cross Timbers and Seymour/Blaine aquifers.

10. Report from Texas Water Development Board or their staff
11. Consider and Act – creation of GMA 6 website and archive of administrative documents
12. Discussion – receive report on the status and any anticipated changes to each district's Groundwater Management Plan and/or Rules.
